### Release, Waiver of Liability and Assumption of Risk

I, the undersigned, understand and hereby acknowledge and agree that participation in rowing/sculling involves certain risks and dangers which include, but are not limited to, exposure to cold weather and water. In consideration of my request to engage in rowing/sculling activity, accompanied or unaccompanied (meaning with or without launch), using Orillia Rowing Club (hereafter referred to as the Club), or private equipment, I agree not to hold the Club, its Directors, Officers or Agents, including coaches, employees and members, liable for personal injury, death and/or property loss. I agree that it is my responsibility to ensure that I do not have any medical condition(s) that might put me at risk when participating in a strenuous activity. I further agree and acknowledge that:

- I have read the safety check list and rules and regulations posted in the boathouse and assume responsibility for examining such information for changes and additions;
- I acknowledge and confirm that I can swim;
- I am familiar with and understand the dangers associated with cold weather and water, specifically hypothermia and how to deal therewith should an accident occur;
- I agree to keep updated regarding special activities and programs ongoing at the Club; also to be bound by all rules established by the Club;
- I agree to immediately notify a Club officer or employee of all incidents within my knowledge affecting the Club or its members; also regarding any obstruction or situations in or on the water and surrounding banks;
- I give permission for the Club to obtain and use photographs and/or videotaped footage for training and/or promotional purposes.
- I give permission for the Club to put my phone number and email address on a list in the boathouse for use by members when arranging crew and row times for the current rowing year.

On behalf of myself and all persons entitled under the *Family Law Act*, I hereby release and forever discharge the Club, its Directors, Officers, Agents, Officials, Members or Employees, from all liability, loss, damages and costs arising from any injury, death, loss or damage to my person or property whenever or however caused arising out of, or in connection with, my use of Club premises or property, or my rowing/sculling activity, on water or land, notwithstanding that such injury, death, loss or damage may have been contributed to or occasioned by negligence of the Club, its Directors, Officers, Agents, Officials, Members or Employees.
